The application form must include a short summary (about 500 words) containing the title of the paper, methodology, main proposal, preliminary conclusions and five keywords, as well as the name/surname, title, affiliation, contact information and ORCID code of the participant.

## **ABSTRACTS SUBMISSION REQUIREMENTS**

1. Abstracts must include the title of the proposed topic and its purpose.
2. The volume of abstracts is about 500 words. Abstracts submitted in Turkish, should also be prepared in English.
3. At least 5 keywords (both in original language of the paper and in English) must be indicated under the abstract.
4. We remind you that the texts of the abstracts must be compatible with the topics of the symposium, otherwise they will not be included in e-book and the program of the symposium.
5. Abstracts should be written on A4 paper (210×297 mm), with an interval of 1.25, justified in width, in Times New Roman font 12 points. The page dimensions should be set as 4cm left, 2cm right and 3cm top and bottom.

## **FULL TEXT SUBMISSION REQUIREMENTS**

1. The language of the text shall be Turkish or English. Full texts should be written on A4 paper (210×297 mm), 1.25 intervals, justified-alignment, Times New Roman font 12 points.
2. The page dimensions should be set as 4cm left, 2cm right and 3cm top and bottom.
3. The heading of the text should be typed single-spaced, centered, bold 14 points, all capital letters in Times New Roman.
4. Headings (except for Introduction and Conclusion) should be placed according to their numbering.
5. At the beginning of the text there should be a cover or footnote containing the name and surname of the author(s), title, affiliation, contact information (telephone and e-mail address), and ORCID code.
6. Within the framework of the above features, the volume of tables, figures, summaries and references should not exceed 20 pages.
7. The sources used should be indicated with footnotes in the text and in the references at the end of the text in OSCOLA style.

Abstracts and full texts of the papers will undergo referee review and PLAGIARISM scanning. Papers with a similarity rate exceeding 25% will not be accepted.
